- o Normal clean up will be the responsibility of Gesstwood. Should, however, in the opinion of the caretaker, an excessive cleanup be required, the renter will be invoiced at a rate of \$25.00 per hour.
- o Renter is responsible for all the set-up of tables, chairs and furnishings. Set up may be available, for an extra fee, if arranged at least two weeks in advance

- o Where alcohol is being consumed, proper licenses must be attained and insurance arrangements made with Gesstwood's carrier, Robertson Hall, or suitable equivalent. (For consent to consume alcohol on site, permission must be granted by the Board of Directors in accordance with the procedures as outlined in our Alcohol Policy.)
